In all matters related to the protection of personal data in "Power." Sp. z o.o. the person responsible is Mr. **Rajmund Karkosz**.

The purposes of processing personal data and the legal basis for processing

Personal data of contractors "Power." Sp. z o.o. are processed in order to:

- implementation of legal provisions;
- presenting the offer, establishing, shaping the content, implementation and settlement of the contract;
- for marketing and commercial purposes of the Administrator.

The legal basis for the processing of personal data is art. 6 par. 1 lit. b and c of the General Data Protection Regulation 2016/679 (GDPR) or the consent of the data subject (Article 6 (1) (a) of the General Data Protection Regulation 2016/679 (GDPR).

Providing personal data is voluntary, but necessary to achieve the goal.

Information about recipients of personal data

Personal data of contractors "Power." Sp. z o.o. they may be transferred to entities authorized under the law and to technical and organizational service providers, in particular ICT services, as well as courier and postal services.

The period during which personal data will be stored

Personal data of contractors in "Power." Sp. z o.o. are kept for a period necessary to achieve the goal, including for accounting and tax purposes, in accordance with the applicable regulations and the period of limitation of claims related to the implementation of the objective.

Rights of contractors in connection with the processing of personal data

The Supplier of "Power." Sp. z o.o. You have the right to request access to your personal data, and in case of necessity, to correct, delete or limit their processing or object to their processing and the right to transfer data if the processing takes place in an automated manner.

If the processing of personal data is based on the consent of the contractor, the contractor has the right to submit a statement on the withdrawal of any consent given at any time. Withdrawal of consent does not affect the legality of the processing, which was made on the basis of consent before its withdrawal.

Providing personal data for the purpose of implementing civil law contracts is a contractual and contractual condition. In the absence of personal data by the contractor, the Administrator will not be able to conclude an agreement with the contractor or perform orders.

Information on the right to lodge a complaint to the supervisory body
